The Chairman and Secretary for the Noxious Weed Management Advisory Board shall be elected from the members set forth above that are appointed pursuant to C.R.S. 35-5.5-107. All recommendations from the Noxious Weed Management Advisory Board to the Board of County Commissioners of Jackson County shall be in writing and signed by the elected Chairman of the Advisory Board. In addition, all recommendations to the Board of County Commissioners of Jackson County that are determined by vote of the members of the Noxious Weed Management Advisory Board shall be accompanied by a written record of the vote, either AYE or NAY, following the name of each member voting. This requirement for recording a vote would not apply where a recommendation was made pursuant to a unanimous vote of the members.

NOW, THEREFORE, BE IT RESOLVED, that the foregoing committees and positions are hereby comprised of the respective persons herein-above named, and that those persons named are hereby appointed to the board unless otherwise provided by law, it being understood that regular attendance at meetings is expected and members may be removed by the Board upon failure to attend three (3) regular meetings of the respective body.

BE IT FURTHER RESOLVED, that it shall be the duty of the elected Secretary of each of the foregoing committees or boards to keep careful records of all business done in meetings of said committee or board, to include the date, place, time of meeting, name of person presiding, names of members present, summary of business and discussion, exact wordings of all motions and whether said motions lost or carried, and to furnish copies of said minutes to this Board on the Monday following the meeting of said committee or board.

The above and foregoing Resolution was, on a motion duly made and seconded, adopted by the following vote on the 10th day of January, 2024.
